

## END USER AGREEMENT (INDIVIDUAL)

July 2017

### Acceptance of Terms

When you click on the "I Consent to be Verified" button, you agree to these Terms, to accept our "cookies" and acknowledge our Privacy Notice (collectively the "Terms").

If you do not agree to all of these Terms, close the browser window immediately and do not proceed. If you do not accept these Terms, you will not be entitled to use our services and must not proceed. iSignthis reserves the right at our discretion to make changes to these Terms. Upon any change, we will post the updated Terms on our website.

You agree to accept electronic communications, links to and/or postings of any revised Terms and that such electronic communications, links and/or postings constitute notice to you of any new or different Terms. Your continued use of any iSignthis services constitutes acceptance of the changes and an agreement to be bound by these Terms, as amended. If you do not agree to the changes, you are not entitled to continue to make use of the iSignthis services.

When using or accessing services offered through third party service providers, you will be subject to terms posted by the service providers. Use of third party services, or acceptance of their terms of service, as the case may be, signifies your agreement to their terms and conditions of service.

In order to register or use iSignthis services, you must be at least 18 years old and legally capable to enter into contracts, and be the holder of a payment instrument that includes a valid credit or debit card, or operate bank accounts with direct debit access.

You may only use the iSignthis services for your personal, individual use. You may not use the iSignthis services for commercial purposes and may not resell or otherwise provide other persons with access to the iSignthis services using your password or user name.

The terms "you" and "user" and "End User" refer to the person that registers for the iSignthis services or has their identity verified, payment processed, or payment authenticated via a iSignthis service on behalf of one of our Merchants and/or iSignthis eMoney Ltd.

Where we collect payment directly as a merchant, it is via iSignthis B.V. in the Netherlands, with Conditions of Sale per below.

### Definitions

**"Payment Instrument"** includes any credit/debit card, virtual card, bank account, direct debit, eWallet, eMoney or eMandate. We reserve the right to introduce additional payment instruments without notice or amendment of these terms.

**"iSignthis"** includes iSignthis B.V (Netherlands KVK 60762187), Authenticate B.V. (KVK 62744968), Authenticate Pty Ltd (Australian ACN 600 573 233), iSignthis UK Ltd (Company Number 10002662), iSignthis Inc (a Delaware Company), iSignthis (IOM) Limited (Company Number 130619C), iSignthis eMoney Ltd (Company Number HE 348009), ISX IP Ltd (BVI Company Number 1842689) and their subsidiaries.

**"iSignthis eMoney Ltd"** means iSignthis eMoney Ltd (Cypriot HE 348009), of Athalassa Avenue 26, Strovolos, 2018, Nicosia, Republic of Cyprus, which is a eMoney Monetary Financial Institution #115.1.3.17 authorised by the Central Bank of Cyprus with freedom to operate within the European Economic Area.

**"Merchant"** includes any entity, including a payment service provider, that refers You, the End User, to the iSignthis service for any of identity verification, payment processing, payment authentication or any other payment service, including antimoney laundering, antifraud and counter funding of terrorism transaction monitoring.

**"Payidentity Profile"** means the identity and payment profile that we create and store based upon your personal data and payment data provided during any identity verification or payment process.

### **Payment of Service Fees and Additional Charges**

We charge our fees to Merchants, payment service providers, payment processors, AML obligated firms, and Financial Institutions. Except where you are being identified as part of a Merchant on-boarding process as either a person of significant control or an ultimate beneficial owner, the iSignthis services is usually free of charge to payment account holders, and you will be told prior to provision of any services, if you are being asked to make a payment to use the iSignthis services.

Any other fees associated with your financial institution accounts will continue to apply. You are responsible for any and all telephone access fees and/or Internet service fees that may be assessed by your telephone and/or Internet service provider.

### **Service Limitations**

iSignthis is unable to foresee or anticipate every technical or other difficulty with the iSignthis services. The third party services or iSignthis services may contain errors, bugs, or other problems from time to time. These difficulties may result in loss of data, personalization settings or other service interruptions. For this reason, you agree that, except as explicitly stated otherwise in these Terms, the iSignthis services are provided "AS-IS", without warranties of any kind. iSignthis cannot assume responsibility for any failure to authenticate, timeliness, deletion, mis-delivery, or failure to store any user data, communications, or personalization settings.

### **Service Changes and Discontinuation**

iSignthis reserves the right to change or discontinue, temporarily or permanently, the iSignthis services at any time without notice. You agree that iSignthis will not be liable to you or any third party for any modification or discontinuance of the iSignthis services.

iSignthis reserves the right to alter features, licensing terms, or other characteristics of any version of services that it releases.

## Usage Rules

For the benefit and security of our users, and to comply with applicable laws, we have a few mandatory guidelines that we call " Usage Rules". Any conduct that violates the Use Rules is grounds for refusal to provide the iSignthis services and for termination of your iSignthis services account.

- **No Anonymous Networks.** We will not allow you to use our service if you use technology that hides or makes your network or devices anonymous in any way. We are here to create a safe online environment for consumers and merchants, and must have some minimum information to create a trusted environment.
- **Provide Accurate Information.** You agree to provide true, accurate, current, and complete information about yourself and your accounts maintained at web sites that provide third party services, information as requested in iSignthis' registration form (or at our partner sites) and account setup process, and you agree to not misrepresent your identity or your account registration information. - **Protect Your PINCode.** You are responsible for maintaining the confidentiality of your PINCode, and ensuring that your mobile phone is not accessible by others. You are fully responsible for all activities that occur using your PINCode and any one-time password we send to your mobile phone. Please notify the issuer of your payment account immediately of any unauthorized use of your payment account or any other breach of security. We will not be liable for any loss that you may incur as a result of someone else using your PINCode and/or password sent to your mobile phone, or unauthorised use of your payment account, either with or without your knowledge, under such circumstances. You may not use anyone else's password at any time. This also applies to any passwords required for use of other services provided by iSignthis' partners.
- **Customer Service Requests.** If you request end user customer service assistance or report a problem with the iSignthis Service, it may be necessary for iSignthis, iSignthis eMoney Ltd or our Merchant Customer's service operators to access your account and view your account information.
- **Respect the Law.** You agree not to use the iSignthis services Service for illegal purposes or for the transmission of material that is unlawful, harassing, libellous (untrue and damaging to others) invasive of another's privacy, abusive, threatening, or obscene, or that infringes the rights of others. - **Proprietary Rights.** You acknowledge and agree that iSignthis and/or its licensors or suppliers own all rights to this website and the iSignthis services, the content displayed on the site and any intellectual or proprietary property and/or technology

(in any form) made available to you as a part of or in conjunction with the iSignthis services. You are only permitted to use any the foregoing as expressly authorized by these Terms and otherwise by the iSignthis services. You may not copy, reproduce, distribute, or create derivative works from any content. Further, you agree not to reverse engineer or reverse compile any technology associated with the iSignthis services, including but not limited to, any software applications or Java applets associated with the iSignthis services.

- **At least 18 years of age.** With regards to the iSignthis evidence of identity service, the service is not intended for use by persons under the age of 18. If you are under 18, you may not use the iSignthis services or download a mobile version of it, and you may not provide us with any of your personal details. iSignthis will not knowingly collect any personal information of persons under 18.

### Rights You Grant to iSignthis

- **Content You Provide.** Subject to iSignthis' Privacy Notice, you are licensing to iSignthis any information, data, passwords, materials, or other content you provide to iSignthis and the third party services, or that is retrieved from third party sites at your request (collectively, "Content"). With the exception of personally identifiable information or payment specific data, iSignthis may use, modify, display, distribute and create new material using such Content to provide the iSignthis Service to you, on the basis that it is depersonalised. The use of Content is fundamental to the provision of the iSignthis services. By submitting Content, you automatically agree, or promise that the owner of such Content has expressly agreed that, without any particular time limit, and without the payment of any fees, iSignthis may use the Content for the purposes set out above. ### Identity Profile

The purpose of the iSignthis Paydentity™ services is to process payments and/or to build an identity profile of you based on information provided by you, or obtained through third party providers. Your unique iSignthis Paydentity™ profile will be retained and used by iSignthis and our Merchant Customers (being the merchant supplying you a service or identity service) for purposes including payment processing, legally mandated identity verification, anti money laundering, counter terrorism funding, detection, prevention & response to fraud, and security control.

The payment and identity verification services are provided by iSignthis solely as a service, and any decision made relating to acceptance of your payment and/or verification of your identity is that of our Merchant Customers or iSignthis eMoney Ltd. In agreeing to any identity verification you are agreeing to be pre-verified by iSignthis eMoney for the issuance of e-money, and for iSignthis eMoney to allow your Paydentity profile to be shared with our Merchants, law enforcement agencies, regulators, card schemes, and upstream payment service providers and for your Paydentity profile to be relied upon by other Anti-Money Laundering obliged entities. By agreeing to this pre-verification you are ensuring that your identity profile is held by iSignthis eMoney for European Economic Area (EEA) End Users, or Authenticate Pty Ltd for Australian End Users, as the respective EEA and Australian operating companies obligated under Anti-Money Laundering laws.

By agreeing to have your identity verified you are not committing to the provision of any services, except those which you have expressly asked our Merchant Customer or iSignthis eMoney to provide to you.

In addition to these Terms, the use of your identity profile or parts of it may also be subject to agreements you have directly with third parties. The third parties include our Merchant Customers who sell or provide you with goods or services. iSignthis is not a party to any agreement you may have with any Merchant Customer of iSignthis. If you have a dispute with one or more Merchant Customers of iSignthis, you forever release us, our affiliates, subsidiaries, licensors, suppliers and service providers, employees, directors and agents from any and all claims, demands and damages of every kind and nature arising out of or in any way connected with such disputes.

For the purpose of the European Union's Data Protection Directive 95/46/EC iSignthis eMoney Ltd is a *data controller* and Authenticate Pty Ltd is a *data processor*. iSignthis eMoney Ltd is registered with the Cyprus data protection agency, and iSignthis UK Ltd, iSignthis BV and iSignthis eMoney Ltd are registered separately with the UK's ICO. All data related to EU citizens is stored within the EU, but may, on a case by case basis, be accessed by Authenticate Pty Ltd employees and direct contractors in Australia.

### **Cross Border Transfers of your Information**

iSignthis is committed to adequately protecting your information regardless of where the data resides and to providing appropriate protection for your information where such data is transferred outside of the EEA.

BY USE OF OUR SERVICES YOU EXPRESSLY GRANT PERMISSION FOR YOUR DATA TO BE SHARED BETWEEN ISIGNTHIS EMONEY LTD (Cyprus) and AUTHENTICATE PTY LTD (Australia), which shall be subject to either EU Privacy requirements if You are domiciled in the European Union, or Australian Privacy law if You are domiciled in Australia.

### **Conditions of Sale**

These Conditions of Sale govern the sale of identity services to you by iSignthis BV, and are to be read in addition to the terms and conditions above. ## **1. OUR IDENTITY SERVICES SALE CONTRACT**

Your order is an offer to iSignthis to buy the identity service as recommended by the Requesting Entity. The Requesting Entity is usually one in which you have a direct or indirect relationship, and the Requesting Entity has a requirement to identify you. When you place an order to purchase a identity service from iSignthis, we will send you a message confirming receipt of your order and containing the details of your order (the "Order Confirmation"). The Order Confirmation is acknowledgement that we have received your order, and does not confirm acceptance of your offer to buy the identity service(s) or the services ordered. We only accept your offer, and conclude the contract of sale for a identity service ordered by you, when we accept your successful payment and you provide the identity details we request.
